With reference to the above subject and the proposal submitted by your institution, I am directed to inform that the State Board is pleased to accord Administrative Approval and Financial Sanction of Rs. 4,60,210.00 (Rupees Four lakh sixty thousand two hundred ten only) including GST, in favour of “Chhatna Chandidas Mahavidyalaya”, for undertaking the project “Plantation through Academic Institutions”, inside the open unutilized area for improvement of air quality and biodiversity of the State as well as ecosystem of the area, from National Clean Air Programme (NCAP) fund under the XV Finance Commission Grant.
